Each institution shall review the status of the Linkage every year to determine whether it wishes the Linkage to continue and, if so, any modifications that might be necessary. **Scope:**

6. Conducting study tours and joint consultancy work;
7. Any other activity that is mutually agreed upon and is beneficial to both.

**Term and Expiration of the Agreement**

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of **Five years**. After these **Five years** it will be automatically extended for the same period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the Parties.

Any additions, changes, or deletions to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these representatives.

**Non-Exclusivity:**

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

**Special Provisions:**

1. Each party will take approval from the other party in writing prior to using the latter's name and logo for the activities hereunder on a case-by-case basis.
2. All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.
3. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or



misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.

4. Neither party can misuse this MoU by involving the name of the other without the written consent from the other party.
5. There will be no financial involvement by either of the parties unless otherwise agreed.

### Disputes

If any dispute arises in respect of the MoU, in that case both the organisations will discuss and settle the matter amicably.



## MEMORANDUM OF UNDERSTANDING

NOW THIS MEMORANDUM OF UNDERSTANDING is agreed by and between both the colleges hereto as follows:

### 1. Objectives, Scope and Major Activities

Both institutions agree to encourage the development of the following types of activities:

- Formal exchange of faculty members in specific mutually agreed upon areas of education, research and outreach.
- Cooperate in under-graduate education and training through library as well as laboratory resources.
- Organize joint conferences, seminar, webinar, symposia, or other meetings on subjects of mutual interest.
  - Exchange of academic information and materials.
  - Pursue avenues for student exchange during the academic year.
  - Explore the possibilities for developing joint research programs and collaborations.

### 2. Responsibilities of the Institutions

The two institutions identify that the execution of any agreed upon activity will depend upon the interests and expertise of the individuals involved and the availability of financial resources, space and other resources. Accordingly, the functioning of any exchanges or collaborative programs based on this MoU shall be conferred and determined between the two institutions. It is further expected that both the institutions will be compliant with all applicable legislations of Government of India and State and University policies.

### 3. Duration and Option to Amend, Extend or Terminate

This MoU will become effective when signed by authorities of both institutions. The agreement will remain in effect for five years from the date of signature given below, and may be renewed or amended by mutual agreement of the institutions. The institutions should agree to periodically review the activities undertaken and the progress made and to consult concerning amendments, renewal or termination of this MoU. Either authority may terminate this MoU at any time by providing written notice prior to three months before such termination to the other authority.
