1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

It was the ardent zeal for the upliftment of higher education that some far-sighted gentlemen of Dhaniakhali decided to establish a College for the young boys and girls of the locality. Accordingly in 1976 at the birth centenary of Sarat Chandra Chattopadhyay, the great Bengali novelist, Sarat Centenary College was established as a junior College with higher secondary courses which was later upgraded into a degree college in 1978 with all three streams of arts, science & Commerce being affiliated under the University of Burdwan. The College stands at the heart of Dhaniakhali. It is under the grants-in-aids scheme of the Govt. of West Bengal. The College campus extends over an area of 03 acres.

The College has received UGC recognition under 2(f) & 12B w.e.f 1978. Till date the College has undergone two cycles of NAAC accreditation in 2005 (C++) &re-accreditation in the 2nd cycle 2016 (B). As the only institute of higher learning at the undergraduate degree level in the Dhaniakhali development block, there is a need to develop a network and strong covalent linkage with society. The College encourages and spreads knowledge and value-based education amongst the young mind and thereby enlightens them to build up a career in personal and professional life with an emphasis on all-round development in respect to the modern global scenario.

Vision

The Rigveda says: "Samgacchabhwam Samvadadhwam Sam vo manamsi janatam...". The vision of the college is to impart quality education at the undergraduate level to the students of the locality with a focus on the underprivileged section. The main vision is to synchronize the implications of the Rigveda hymn to modernity. Institutional Weakness

- **1.** Infrastructural weakness: Though the college has made some infrastructural development, to meet the rising demands of the students and faculty it is not sufficient enough.
- **2.** Limited funding for research activities: Inadequate financial resources make it difficult for the college to support research endeavours.
- **3.** Inadequate office staff: At present the college is running very short of full-time office staff. As a result, some administrative lacunas emerge that are beyond our control.
- **4.** Decline in student enrollment and dropout: Since the Covid -19 students' enrollment in college has declined. What is more alarming is that student enrolment in science faculties has become notoriously meager. Moreover, a significant number of students drop out in the middle of their course careers.
- 5. Lack of strong college-industry tie-ups: Sarat Centenary College despite its efforts has not been able to

establish tie-ups with industries or other institutions of national importance

Institutional Opportunity

- 1. The college was established by some local people with an acute interest in higher education. Hence a strong bond of cooperation between the college and neighbourhood has existed from the college's inception. Most of our students neighbouring communities.
- 2. The rural background of the college offers an excellent opportunity for the college to provide a higher educational scope to the students who otherwise would have been deprived of it. The college started with the students, most of whom were 1st generation learners. Now many of them are sending their wards to our college which proves the local upliftment envisioned by the founders has become a reality at least for a section of the locality.
- **3.** An excellent teaching faculty with so many researchers provides immense opportunities for opening up the modern academic world before the students. Especially the science faculty through organizing regular annual science exhibitions to inculcate scientific temperament among the students.
- **4.** There is ample opportunity for SCC to develop its physical infrastructure and we are working on the goal now. The rural base of its locality, massive greenery, rich biodiversity, and efficient human resources can and will help us to create sustainable development in the locality in the near future.

Institutional Challenge

- 1. Infinitesimal financial resources cast a heavy shadow on the prospect of infrastructural development. The challenge is to secure adequate funds for future developmental facilities.
- **2.** Building strong ties with industries is a great challenge to our institution. The rural situatedness may have provided other opportunities to the college but linkages with industries for the benefit of our students are hindered in this case.
- **3.** COVID-19 has seriously undermined the socio-economic structure everywhere, Dhaniakhali is not an exception either. The problem is not unique but rather universal. But what is unique in our case as a rural college, a large number of students are compelled to go out for jobs however precarious they might be. It is a challenge for the college to convince those students in this regard and bring them back to the institution for a bright future.
- **4.** Providing ample opportunity for the teachers to do research and consultancy work is a challenge to the college. The college needs to provide adequate support resources. An incentive to motivate the teachers to undertake research projects and offer consultancy services.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Sarat Centenary College offers fifteen undergraduate courses including B.A, B.Sc & B.Com programmes in honours and general following the Choice Based Credit System (CBCS) designed by the University of Burdwan since 2017. However, since 2023-2024 NEP and CCFUP have been introduced where twenty-eight undergraduate courses were taught.

Curriculum delivery:

Every department has implemented a curriculum plan that is effectively delivered to the students according to the academic calendar prepared by the college. Project work and excursion programmes along with educational tours are organised by a few departments for the effective delivery of the curriculum.

Continuous Internal Evaluation:

All the departments conduct continuous evaluations to ensure that the students understand their lessons. Co-curricular activities are arranged by the college for the benefit and improvement of the students.

Cross-cutting issues:

Professional ethics, gender, human values and environmental sustainability are integral to the issues of the college to help the students cope with the challenges of the outer world. The cross-cutting issues of Professional ethics, gender, human values and environmental sustainability are well integrated and reflected in the existing curriculum with the aim of its enrichment.

Feedback:

The College has collected and analysed feedback from the students in both formal and informal ways regarding various aspects of curriculum delivery, institutional infrastructure, laboratories, library facilities, office facilities and other support services of the institution. The college has taken action to these feedback reports as far as possible.

Teaching-learning and Evaluation

Sarat Centenary College has evinced its commitment towards bold teaching and learning evaluation processes within its academic framework.

Admission (Enrolment):

The College follows a free, fair, and transparent online admission as per the admission circular and the Reservation policies of the State Govt. and the University of the Burdwan. 1st sem enrolment (admission)

percentage (overall) and from the reserve categories are 53.74% and 52.6% over the last five years.

Student – Teacher ratio:

The college has a good healthy student-teacher ratio of 39:1 (last completed academic year i.e. 2022-23) which ensures a dedicated and devoted teaching-learning environment.

ICT Infrastructure:

The College has a robust ICT infrastructure which includes LMS, KOHA, INFLIBNET Subscription, Projectors, high-speed internet, Computer by the latest configurations, PA systems in the large classrooms, multiple smart classrooms, and many others for providing quality education to the students.

Experiential, Participative, And Problem-Solving Teaching-Learning Methodologies:

The College effectively stresses promoting Experiential, Participative, Problem-Solving, and teaching-learning methodologies by conducting practical classes, projects, dissertations, field trips, seminars, workshops, etc. Community engagement extension activities students' seminars, quiz competitions, educational exhibitions, and other co-curricular activities help the students help the students to gain knowledge.

Faculty Profile and Strength:

SCC has a vast pool of human resources as faculty members comprising both young and experienced teachers **95.95** % of full-time sanctioned posts of faculty members are filled as per UGC guidelines. **63.73**% of full-time faculty members are qualified with NET / SLET / SET / P. hD / M. Phill degrees.

Internal and External Examinations:

SCC conducts internal and external examinations as per University of Burdwan regulations. The Teacher's Council centrally monitors the examination procedure through constructing examination committees for each semester. Departments conduct academic progress meetings to ascertain the student's progress, syllabus completion etc. The academic council prepares the academic calendar.

Examination Oriented Grievances:

- Students can apply for a review of their published results within the stipulated time fixed by the University. The College office in this regard pays due attention timely and in a humane manner.
- The College has introduced a mentoring system for the last few years.

Pos, PSOs, and Cos enlistment, circulation, and evaluation of their attainment:

- The Pos, PSOs, and Cos of all the programmes and courses have been designed meticulously by the IQAC and the departments. They have been shared through classroom interactive sessions.
- The evaluation of the attainment of enlisted outcomes (Pos, PSOs, and Cos) is conducted through mechanisms like result analyses, departmental meetings, etc.

Results:

The College has a healthy examination pass percentage hovering above 71.57% over the last five years.

The College conducts student satisfaction survey annually.

Research, Innovations and Extension

Resource Mobilization for Research:

Faculty members of SCC have received four numbers minor research projects from UGC. One of each MRP from UGC in Mathematics, Bengali, English & Political Science received a total rupees 6.96 lakh for the period of 2018-2023. Moreover, the Principal as co-PI has received Rs. 1, 24,57,790/-from UGC, DST, SERB, and DBT in collaboration with West Bengal State University.

Research Publications and Book Publications:

- 53 research papers have been published by different faculty members in the last five years and are under the UGC-Care enlisted category.
- 33 books and book chapters with ISBN have been published by the faculty members during the last five years.

Seminars / Webinars / Workshops / Conferences:

The College has arranged for International and National seminars and a series of webinars.

NSS Activities:

The College has **03** NSS units. Regular extension and outreach programmes have been conducted by the Institution, organised by the NSS units in the last five years

Observation of National Science Day, the Science Exhibition is held in an interdisciplinary way where all the departments participate with models, colorful posters, etc. Interdepartmental teacher exchange has now become a common practice in our College and the students' participation and enthusiasm are points of encouragement to our effort. 'Postscriptum'a multidisciplinary peer-reviewed online journal is being published with high-quality inter-disciplinary research articles from scholars, National and International. An overall multi-disciplinary academic culture is taking place within the College academia.

2. Academic bank of credits (ABC):

The Automated Permanent Academic Account Registry (APAAR)/ Academic bank of credits, a specialist identification system, is meant to be used by all Indian students. Part of the Union government's 'One Nation, One Student ID' campaign, this endeavour is in line with the recently implemented National Education Policy of 2020. All Indian students must register for APAAR/ABC ID, a unique 12-digit code, in order to digitally preserve, manage, and access all of their academic credits—including degrees, diplomas, certificates, training details, and extracurricular accomplishments. In the context of education, this ID acts as a digital identification for the student. Using their APAAR/ABC ID as a link, students can securely save critical documents, such as test results, in DigiLocker, an online repository. It is linked to the Academic Bank of Credits (ABC) by the APAAR/ABC ID and accepts academic credits from institutions via the National Academic Depository. This expedites authentication for employment applications or admissions and makes it easier to verify academic records. In order to increase accountability and transparency in education, APAAR monitors student accomplishment and simplifies academic data. It provides a comprehensive approach to student development by enhancing productivity, combating fraud, and including extracurricular activities. APAAR facilitates data-driven decision-making in educational institutions and expedites the transfer process through a range of applications. It also facilitates the easy sharing of academic data among students, so expanding their options. APAAR facilitates career development, provides academic material that is insightful, expedites administrative processes, and

forges relationships with industry partners in higher education. Along with streamlining administrative duties like record keeping and admissions, it also helps create links between students and employers and offers individualised career guidance. Colleges trust APAAR/ABC ID to handle the details so they may focus on creating settings that support growth in both the professional and academic domains. Following UGC's advice, the University of Burdwan took the initiative to establish academic banks of credit for each and every undergraduate student. The college administration delegated authority to the relevant nodal personnel to assist our students in obtaining their Academic Bank of credits, and they completed the task successfully and on schedule. Before registration, the university made it essential for every single student. The ability for students to store their documents in a free, centrally secured DigiLocker will be greatly aided by this accomplishment. Most of the college's students have created their ABC IDs and registered for digilockers.

3. Skill development:

The CBCS curricula have skill enhancement courses (SEC) which are being efficiently taught by able teachers from all the faculties. Besides these curriculum-based skilled courses, there are ample opportunities in the locality to provide a skill-based training program. Before the pandemic struck the college successfully ran a skill-based training programme on sewing for three consecutive years where nearly 100 numbers peoples mostly women from the locality took training and benefitted. 1.3.1 - Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability into the Curriculum

As an affiliated college, the institute do not have ability to frame the curriculum of any UG course. Although within its limit and preview it integrates cross-cutting issues into the teaching of its curriculum, the college is deeply concerned about issues on Professional Ethics, Gender, Human Values, Environment, and Sustainability which are included in the syllabi of various disciplines.

Professional Ethics are being discussed in the UG syllabi of various subjects. Some of these are-

- The course of Sanskrit includes the topics on 'Ethical and Moral Issues' and 'Art of Balanced Living'.
- The Philosophy course depicts the topic of 'Professional Ethics'.

Gender issues are also being consulted in the UG courses of various streams. Gender and related issues are also depicted like gender biasness, gender discrimination in the workplace, gender violence, etc. A few of these are-

- The English department offers to study 'Woman and Empowerment', highlighting the issues on the social structure of gender.
- Bengali department also emphasizes the issues of gender and woman empowerment as well as the environment in their various poems and novels.
- The curricula of the departments related to literature and social sciences offer topics on Gender comprising Gender and Politics, Gender sociology, Gender sensitization, Philosophy, etc.

Human Values and Professional Ethics are reflected in various courses like -

- The curricula of Education, English, Philosophy, Political Science, etc.
- The Skill Enhancement Course of Education offers 'Value Education'.
- Human values are being discussed in their classes in a routine manner.

The issues of Environment and Sustainability are being discussed in different courses of many disciplines like Botany, Zoology, Chemistry, Geography, Bengali, Political Science, etc -

- The students of Semester I of each discipline have Environmental Studies as a paper including a mandatory project for the Ability Enhancement Course with four credits to gain knowledge on environment and sustainability.
- The curriculum of the Botany course reflects the issues on the environment and its protection as well as the bioethics. Plant Ecology, Phytogeography, Economic Botany Natural Resource Management, Industrial and Environmental Microbiology, etc.
- The NSS units of the college also organized various awareness programs on the environment.
- Besides these, the college also observed World Environment Day, National Science Day, etc.

The above-mentioned courses are some examples, actually almost all the courses of various disciplines integrate the issues related to Professional Ethics, Gender, Human Values, Environment, and Sustainability.

2.5 Evaluation Process and Reforms

2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

As an affiliated college to the University of Burdwan, Sarat Centenary College has designed its assessment mechanism process in accordance with circular provided by the University, encompassing mainly two types: end-term or external assessments and internal assessments. The introduction of the CBCS mode of teaching-learning since 2017 has formalized and structured the internal and external assessment system. The assessment ratio stood at 80:20 for external assessments and internal assessments respectively, indicating a balanced approach to evaluation. Adherence to the guidelines set forth by the affiliated university is strictly maintained during internal assessments and end-semester examinations, emphasizing accountability and quality assurance. Besides, most of the departments conduct ongoing assessments throughout the academic year.

End-Term or External Assessment: External assessments are summative evaluations conducted at the conclusion of a course to gauge the students' overall understanding of the curriculum. End semester university examinations are conducted to assess the students' academic performance.

Internal Assessment: Internal assessments are formative evaluations that occur continuously during the course, providing insights into students' learning and receptivity at regular intervals. Regarding the Core Courses, 10 marks are allotted in the forms of written examination, assignments, and viva by the respective departments and 5 marks are allotted for the Attendance of the students(exceptfor SEC courses). The respective departments use their discretion to conduct Internal Evaluation for their Honours students, whereas, Internal Examinations for General and Generic courses are conducted centrally under the supervision of the Examination Committee. Marks of Internal Assessments are preserved by the Departments and uploaded by the respective departmental teachers in the University portal in due time.

Ongoing Assessments by Departmental Teachers: Departmental teachers conduct assessments throughout the year to evaluate students' analytical thinking and descriptive knowledge, encompassing surprise class tests, class lectures, and participation in cultural and social activities. These assessments contribute to the overall evaluation of students' achievements and help in understanding their progress and receptivity.

Salient Features of the Assessment Process:

The college has an Examination Committee headed by the Principal as the Officer -in-Charge. A teacher is appointed as Assistance Officer -in-Charge and has support staff to ensure the smooth functioning of exams.

- The date of the internal examination is planned well ahead in the meetings held by the Examination Committee, Teachers' Council and Academic Council.
- The pattern of the examination (e.g. 2,5,10 marks) is explained in detail by respective teachers. Occasionally, multiple-choice questions are incorporated, compelling students to engage in indepth subject study.
- The College website has information related to examinations published on a regular basis.
- As per CBCS guidelines, the secured marks of internal evaluation are added to the final score of
 the University examinations. Since it is confidential in nature, student specific disclosure is not
 permissible.Questions, queries, and doubts regarding evaluations are addressed and clarified as
 quickly as possible

The emphasis on transparency, grievance redressal, timeliness, and efficiency ensure a fair and supportive environment for students as they progress through their academic journey.

At the start of each course, the concerned teacher verbally communicates the outcomes. The college has set clear learning goals for every academic program, along with its vision and purpose. Program Outcomes (POs) and Program Specific Outcomes (PSOs) play a crucial role in maintaining the quality of each graduating program. When designing the curriculum by our affiliating University for each department, all POs were taken into account, ensuring that PSOs are aligned with the curriculum. Course Outcomes (COs) are short statements that use specific, measurable language to describe what students

will learn during the program. POs and PSOs are used to map these COs, ensuring that they are in line with the program's objectives. At the beginning of each semester, the course lead checks how well the COs match the POs/PSOs. Throughout the semester, the course is regularly reviewed using various assessment methods to see if students are achieving the COs.

PO-CO Attainment and Evaluation:

This involves both direct and indirect methods of attainment. In the direct method, Course Outcome and Programme Outcome attainment are assessed based on students' results in various assessments conducted by the respective departments and affiliating university. In the indirect method, Program and Course Outcome attainment is evaluated through communication over phone/email/ whatsapp by the concerned departmental teachers on students' progression.

Direct Methods for Evaluating PO-CO Attainment:

- Assignments and internal examinations carry the primary weightage in evaluating the attainment
 of POs and COs within the institution's educational framework. These methods directly measure
 students' performance, understanding, and application of the learning objectives outlined in the
 curriculum.
- Assignments entail tasks and projects designed to assess students' comprehension, critical thinking, problem-solving abilities, and application of theoretical knowledge to practical scenarios.
- Internal exams, conducted within the classroom or institutional setting, evaluate students'
 mastery of specific subject matter, providing a structured assessment of their knowledge and
 skills.
- Student feedback, carry some weightage in the teaching-learning and the evaluation process.

Indirect Ways to Evaluate PO-CO Attainment:

- The evaluation of POs and COs extends to students' progression into higher education or pursuit of professional courses.
- A significant number of students become eligible to participate in NET, SET, GATE and different competitive examinations conducted by both State and Central Governments.
- The active participation of students in various extension programs and campaigns by the NSS
 focused on civic and environmental awareness, coupled with their confidence in competitive
 exams and interviews, serves as an indirect confirmation of the academic knowledge and skills

6.3 Faculty Empowerment Strategies

6.3.1

The institution has performance appraisal system, effective welfare measures for teaching and non-teaching staff and avenues for career development/progression

Response:

Sarat Centenary College has adopted a comprehensive performance appraisal system and a range of welfare initiatives for its teaching and non-teaching staff. Emphasizing equitable assessments, financial security, ongoing professional development, and leisure activities, the college underscores its dedication to the wellbeing and satisfaction of its employees.

Self Appraisal System

The performance appraisal system of the teachers is conducted in accordance with the guidelines set by the UGC, the State Government, the affiliated university, and the institute's own procedures. Basically the structure laid down by the mentioned authorities is compulsorily followed for Career Advancement Scheme (CAS).

Teaching staff provide self-appraisal reports of their service, daily activities, research, and extension efforts. These reports are reviewed by the Principal and the IQAC Coordinator.

Welfare Measures for TS and NTS:

The institution supports the interests of both teaching and non-teaching staff through a variety of welfare initiatives. It covers welfare in terms of financial, medical and overall perspective of the employees as follows-

- Group Savings Linked Insurance Scheme (GSLI)- Both teaching and non-teaching members can join the Group Savings Linked Insurance Scheme until 2011, with 18 members currently enrolled.
- West Bengal Health Scheme (WBHS)- The Scheme offers cashless medical treatments up to Rs. 2 lakhs for permanent teaching staff at designated hospitals, with government reimbursement for expenses exceeding that amount.
- **Child Care Leave-** Apart from Maternity leave for 180 days child care leave of 24 months for up to two children for female staff.
- Commuted Pension and Gratuity- At the time of superannuation from the job an employee availed commuted pension and gratuity.
- **Final General Provident Fund Payment-** During the superannuation time an employee received the final payment of accumulated PF with interest.

- Non-Refundable General Provident Fund Loan- An employee can avail the benefit of Non-Refundable General Provident Fund Loan during the service tenure.
- Sarat Centenary College Employees Co-operative Credit Society- Through this society all the member enjoyed loan facilities according to the urgent need. Moreover, it provides individuals accumulated amount at the time of retirement.

Career development/progression:

The IQAC supports teachers in developing research and seminar proposals and encourages their involvement in research activities. Promotions and CAS benefits are provided in accordance with UGC and State Government regulations. Training through the HRMS system improves staff skills, including the use of ICT in teaching. Permission for RC/OP/STC and transfer of TS is granted in line with government orders. Non-teaching staff receive benefits for 10 and 20 years of service.

College provides recreational facilities like table tennis and gymnasium, accommodations for differently-abled individuals, e-governance initiatives, air-conditioned staff rooms and college offices, water purifiers, parking facilities, canteen, water purifier, 24x7 power back-up, surveillance by CCTV, identity card to the teaching and non-teaching, access to an interdisciplinary journal of literary studies, and open elearning resources in the college library.

Response:

Sarat Centenary College employs effective financial strategies to mobilize funds from various sources, ensuring their optimal utilization for comprehensive institutional development and student welfare.

The college's financial strategy implementation typically follows these steps:

- 1. **Requisition Submission:** Departments, IQAC, or other units submit requisitions.
- 2. **Finance Committee Review:** The requisitions are presented to the Finance Committee for approval.
- 3. **Governing Body Approval:** The Governing Body (GB) approves the Finance Committee's recommendations.
- 4. **Purchase Subcommittee Involvement:** The Purchase Subcommittee is engaged to oversee procurement.
- 5. **Tender Process:** A formal tender process is conducted as per government regulations.
- 6. Fund Utilization: Finally, the funds are utilized according to the approved plans.

Funding Sources and Procurement:

- Government Grants: The college receives financial support from the Government of West Bengal, the University of Burdwan, and the Government of India for various activities.
- Scholarships and Grants: The institution actively seeks scholarships and grants from state and central government bodies, as well as private agencies. These financial aids support students from SC, ST, OBC backgrounds, general meritorious students, and female students, contributing to their overall development.
- **UGC Funds:** During the tenure, the college successfully procured and utilized UGC-MRP grants. Additionally, it completed the necessary procedures for the settlement of UGC Plan-XI and Plan-XII funds.
- **Student Fees:** Funds collected from students for various purposes are managed efficiently and used for their intended purposes.
- Covid19 Fund: Contributions were made by both teaching and non-teaching staff during the pandemic.
- Other Sources: Additional funds are generated through activities such as scrap clearance, seminar registration fees, room rentals to different agencies, and NSOU.

Mechanism of Fund Utilization:

The college employs a robust financial system that meticulously manages bills, vouchers, balance sheets, audit statements, income, expenditures, and fund utilization processes to prevent mismanagement.

- **Necessary Approvals:** The Finance Committee and Governing Body must approve all financial decisions.
- Estimates & Tendering: Detailed Project Reports (DPR) are prepared in line with government guidelines, vetted, and followed by the tendering process.
- Work Process: Orders are placed, and payments are made upon the completion of work.

Internal Financial Management:

The college ensures rigorous financial scrutiny by committees appointed by the Governing Body for every transaction and during the preparation of the annual budget. The accounts department verifies all data before final approval by the Bursar and Principal. The Purchase and Tender Committee plays a crucial role in fund procurement.

External Audit:

At the end of each financial year, an external audit of all financial transactions is conducted by a Chartered firm appointed by the Government of West Bengal. The firm examines the balance sheet, covering incomes, expenditures, receipts, and payments. The college strictly follows and implements the external auditor's recommendations through the accounts department.

The Internal Quality Assurance Cell (IQAC) at Sarat Centenary College plays a vital and forward-thinking role in improving the overall quality of education and related activities. Responsible for upholding and standardizing quality assurance strategies and processes, the IQAC has been central to fostering a culture of continuous improvement among all stakeholders.

Initiatives by the IQAC:

- The IQAC at Sarat Centenary College actively formulates strategies to ensure quality assurance and smooth functioning of the teaching-learning process.
- Implements various techniques to align with the college's vision, creating a roadmap for ongoing development.
- Recommends the establishment of a Discipline and Code of Conduct Sub-Committee.
- Manages the implementation of a 365-day academic calendar and an administrative calendar.
- Ensures adherence to the code of conduct by the Governing Body, Principal, teaching and non-teaching staff, and students.
- Plays a key role in the successful completion of NAAC and AIHE accreditation processes.
- Organizes regular meetings with stakeholders (faculty, office staff, students) to maintain open communication and address concerns.
- Collects and reviews feedback from stakeholders to enhance the teaching and learning process.
- Prepares the Annual Quality Assurance Report (AQAR) in accordance with guidelines.
- Facilitates faculty promotions under the Career Advancement Scheme (CAS).
- Encourages participation in Faculty Development Programs (FDP), Management Development

Programs (MDP), training sessions, and administrative programs.

• Supports collaborative research activities and partnerships with other institutions.

During the pandemic, the IQAC proactively addressed the challenges presented by the unprecedented situation, implementing several key strategies and these are properly maintained in post-pandemic period also accordingly:

1. Reviews on Teaching-Learning Process:

- Teaching-Learning Process and Online Resources: In response to the pandemic, the IQAC facilitated the adoption of a G-Suite Account (education version) for online teaching, learning, and examinations at Sarat Centenary College. Other web platforms like Google Meet, Zoom, Discord, Skype, and YouTube were also used for educational purposes, including organizing webinars. Faculty members created e-content aligned with the CBCS syllabus, which was made available on the college website for broader access.

3. Various Activities:

Response: Sarat Centenary College was established as a co-education center for higher learning. Naturally from the very beginning, the college authority was well aware of the intricacy of gender sensitization. The college is going to celebrate its golden jubilee a couple of years from now. In this long journey through five decades, SCC can boast itself of the fact that it has maintained gender equality in all the segments of its work schedule. Activities undertaken by the college in this regard are as follows:

- 1. Women's cell: a women's cell was founded to facilitate the working towards gender sensitization.
- 2. Gender audit: SCC has organized an external gender audit through its women's cell.
- 3. Kanyashree Scholarship (K2 UG Level) exclusively for the girl child has been executed and recommended through the college office. The college was awarded for best performance in Kanyashree within the Dhaniakhali Development block in 2019.
- 4.A number of courses include gender issues taught by the departments of History, English, Geography, etc. The Department of English teaches the writings of a number of women writers. The Department of History teaches the general students two papers on women's studies and gender and education in India.
- 5. The college has three NSS units. In all three units, the number of female volunteers significantly exceeds that of the males.
- 6. Women empowerment in college administration: Though the number of women staff in comparison to male staff is less but several internal committees to assist the administration are represented by women staff. Presently the Assistant Teacher's Council Secretary is a lady teacher, she has been in the post for the last two years.

7.2 Best Practices

7.2.1

Describe two best practices successfully implemented by the Institution as per NAAC format provided in the Manual

Response:

Best Practice-I: Provision of scholarship from Govt as well as from college funds

Context:

Higher education in India has become expensive in recent years and financially backward students are its worst victims. The Govt of West Bengal has come out with a great deal of student scholarships and other financial help to a large number of students enabling them to get higher education for upliftment of the society. The college acts as a mediator between the Govt and students in getting financial help as offered by the State Govt in the form of scholarships and others. But such support from the end of the Govt is not sufficient to cater to the needs. Multi-dimensional poverty on the way of higher education may not be eradicated only by such Govt initiatives. For the students who do not receive Government-level support mechanisms but are financially backward, the college made an effort to identify and support them from its own fund in terms of half/full free ship of college tuition fee and by a provision of Students' Aid Fund.

Objective:

- To provide support to the needy and meritorious students.
- To remove the financial obstacles for the learners on their way to higher education.
- To identify the students who are not obtaining any Government-provided scholarship.

Practice:

The college always tries to remove the financial obstacles of the financially poor and needy students by enabling them to get full-free and half-free scholarships from the college fund. Moreover, the poor students who do not receive government scholarships are entitled to get the Students' Aid Fund from the college.

The college has a subcommittee of Students' Welfare chaired by the principal and a teacher as convener with teacher members and student representatives, office staff, duly set up by the Governing Body. After receiving applications from the applicant students, the committee needs meticulous scrutiny and discussion, and a list of the beneficiary students is published.

In 2018-19 total of 148 students received the benefit of half/full free ship of which 30 were male students and 118 females. It is to be mentioned here that after the introduction of CBCS half / full freeship became somewhat inconvenient for the semester system. The college authority then took a decision that as most of the students of the college receive somewhat Govt scholarship, those students who do not fall into these categories and of the general category and poor would receive financial assistance from the college. During the Corona period i.e., 2019-20, 2020-21 the college reduced tuition fees, library fees, electricity fees etc. but no financial assistance could be done. In 2021-22 and 2022-23, total of 96 students benefited with Rs. 54, 820/- as financial assistance.

Problem Faced and Resource Required:

SCC is situated in a rural background and the students who come to this college are mostly from poor backgrounds. Though a large section of students receive Govt scholarships still a considerable number of students are left out of these schemes. The college tries to meet the needs of these students but it seems that it is a quite small amount. Financial constraints debarred the college from providing a sufficient amount to needy students.

Evidence of Success:

The financially backward students who do not receive any Government-provided scholarship benefited from half /full free-ship and Students' Aid Fund. During the Corona period i.e., 2019-20, 2020-21 the college reduced tuition fees, library fees, electricity fees etc. but no financial assistance could be done. In 2021-22 and 2022-23, a total of 96 students benefited from Rs. 54, 820/- as financial assistance. In 2018-19, a total of 148 students benefited from the half/full free-ship scheme. These initiatives taken by the college have been extremely beneficial to our students especially during and after post pandemic situation.

Best Practices – II: Publication of online journal

Objective:

The publication of a bi-yearly journal by a college is a quite noteworthy event. Sarat Centenary College publishes an interdisciplinary online journal 'Postscriptum'(ISSN:2456-7507) managed and edited by the Department of English with financial support from the college authority.

Context:

The interdisciplinary approach is imperative to modern academic practices. Under the impulse of globalized economic order academic exercises have become more nuanced and inclined towards interdisciplinary modulation. Hence the publication online journal Postscriptum.

Practice:

Postscriptum is being published from 2016 onwards. Outstanding articles from regional, national, and international scholars have been published in the journal. In the last five years (2018-2022) total of 135 articles have been published. At present the website is maintained by the college.

Success:

Postcriptum had been on the UGC-approved list till 14.06.2019. At present it is indexed in open AIR, Directory of Periodicals in Modern Language Association, DOAJ, ROAD, FATCAT, ZDB, SUDOC, etc. The number of clicks (up to June 2024) is 1.51K. 27.6K impressions have been registered. Publication in this Journal has helped a number of young teachers in their respective CAS.So an initiative from a comparatively regional rural college the achievement in this regard is no small. A total of 15 volumes have been published so far with 166 articles of which 29 are from overseas scholars and 7 book reviews and 2 interviews have been published.

Problems Encountered and Resources Required:

1. Presently the Journal is managed and edited by a single teacher from the English Department, Dr Ramanuj Konar. Workload sharing is a problem in this regard.

More funds are needed for better accomplishment of the e-journal.

7.3 Institutional Distinctiveness

7.3.1

Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

Response:

Preservation of native bio-diversity and saving the environment for sustainable development.

Environmental degradation, loss of biodiversity, and climate crisis are looming at large like the 'Sword of Damocles' on humanity in general. A higher learning center can not shy away from these great dangers at any cost. Sarat Centenary College, despite its limited capacity, has joined the rest of society to combat the dangers of the climate crisis through various initiatives taken over the last five years.

Green Audit:

The College has done regular internal green audits so that the preservation of biodiversity in the surroundings is maintained. With the collaboration of West Bengal State University, the College took the initiative for the Edaphic and Water criterion (Physical and Bio-Chemical) Evaluation of Sarat Centenary College. It was done with data generated by the environmental Bio-technological laboratory, at West Bengal State University. The green audit conducted by the Botanical Survey of India (BSI) recently has expressed their satisfaction with our green initiatives.

Energy Audit: All the stakeholders of the Institution are very much conscious of energy saving. Erstwhile tube lights and bulbs are replaced with LED lights and thus saved power consumption to a considerable extent. AC is now almost necessary but the college encourages the stakeholders to use AC rationally. The College on its own initiative conducts energy audits every year. Recently a team from Jadavpur University conducted an energy audit of the College. The results are satisfactory and vindicate the college's energy-saving initiatives.

NSS Activities: The three units of the NSS take initiatives to protect the native environment and inculcate a strong ecological sense in their volunteers. Organising seminars, webinars on environmental degradation, sapling plantations on the campus and in the adopted villages, making the local people aware of the dangers of using single-use plastics, etc. are the normal activities of the NSS. These activities are related to the preservation of the native environment.

Departmental Activities:

The Department of Geography conducted fieldwork on disaster management in nearby locations. Though the fieldwork falls within the curricula, still the fieldwork itself as it was done on primary data, involvement of the local populace extends the fieldwork beyond academic paraphernalia. This fieldwork creates awareness among the local people concerning natural disasters like floods etc. which cause severe loss in biodiversity.

Protecting Native Environment:

The College campus itself is rich with bio-diversity. A pond inside the campus is an example of a niche environment. The College took the initiative to renovate the pond recently so that the niche environment may be protected. There is an age-old tamarind (*tamarinda indica*) beside the pond. The college takes care to maintain the tree and its surroundings. The local people have a special sentiment for the tree which the college appreciates. It has become a part of the local heritage of which the college is proud of. Plenty of trees inside the college campus not only add to the beautification of the college, it also serves the purpose of environmental richness and examples of healthy bio-diversity. Nature adorns variety and Sarat Centenary College with its rich environmental niche adheres to the task of protecting the varieties of Nature.
